The Astro PFP FR Putty Seal is supplied precut to size with a peel off strip to both faces to prevent it from bonding materials other than for the desired application. The Astro PFP FR Putty Seal is installed by removing the peelable strips and wrapping the pad around the socket box where it penetrates the face of the wall and covering the back face of the box (at the end of the pipe). When installing around service penetrations, the Astro PFP FR Putty Seal is installed by removing the peelable strips and wrapping the pad around the service where it penetrates the face of the wall or floor.
